News from ETFplus market

- 20 new ETFs listed during Q3. As of September 2017, 1108 ETPs were listed on the ETFplus market (16 issuers)

AUM in Italy

- As of September 2017, total ETP AUM deposited in Italy reached €64.89bn, +25.90% vs September 2016
- Q3 2017 saw more than €2bn of inflow vs Q3 2016 (+5.10%)


Trades (Q3 2017)

- Borsa Italiana has cemented its leadership in Europe for the number of trades on an electronic platform with a market share of 30.1%, a ranking that has been held since 2005
- 938,876 trades with a countervalue of €22.30bn







Market spread

AUM in Italy and Net Inflow






